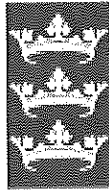

Supply of Alcohol:

n/a

Door Supervision:

Any individual carrying out security activity at the premises must be:

- (a) Authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
- (b) Be entitled to carry out that activity by virtue of section 4 of that Act.

Exhibition of films:

Where the film classification body is specified in the licence, unless subsection (2) (b) applies, admission of children must be restricted in accordance with any recommendation made by that body.

Where:–

- (a) the film classification body is not specified in the licence, or
- (a) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.

In this section – “children” means persons aged under 18; and
“film classification body” means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984 (c.39) authority to determine suitability of video works for classification.

Annex 2: Conditions consistent with the operating systems.

General – All four licensing objectives:

The license will be operated for staging the outdoor performance of Epicycle by CirkVost. CirkVost are experienced circus artists who have toured and performed the show Epicycle since 2010 over 200 times. The event preparation and build will be managed by CirkVost, Hull 2017 UK City Of Culture and T G Events, who have experience in planning and operating in similar locations.

An Event Management Plan will be written which will cover all licensing objectives and be distributed prior to ESAG on 13th July and 10th August for full details and the opportunity for comments prior to the event.

Each EMP shall be distributed for consultation and comment to ESAG members. The EMP must be agreed in writing 21 days prior to the event by the Environmental Regulation, Health and Safety Departments of Public Protection, Hull City council and the Humberside Police Licensing Department.

The prevention of crime and disorder:

If identified as necessary from a risk assessment and Event Management Plan, Crowd Management plans will be in place and detailed in the Event Management Plan.

Qualified SIA staff will be employed and briefed to assist with the safe delivery of activity prior to, during and finishing the event to ensure the premises is safe from theft and behaviour.

Public safety:

Crowd Management plans will be in place and detailed in the Event Management Plan.

Stewards will be briefed of the project to assist with ensuring public safety during the delivery of the project.

The prevention of public nuisance:

Hull 2017 UK City of Culture will work closely alongside contractors and artists to ensure minimal environmental and social impact to the premise.

All involved will consider safe and efficient access and egress to the premise when planning the event to ensure minimum public nuisance.

The protection of children from harm:

Any age- restricted content in the performance will be highlighted to the public prior to the event through marketing and digital materials.

If a "lost child" point is identified as required through an Event Management Plan and Risk Assessment a reputable and experienced company will be appointed and all persons staffing said point will have undergone the appropriate DBS checks with regard to safe-guarding children.
